We award medals for the top three in each division. We offer standing self-defense, GI and NOGI Jiu-Jitsu and Judo divisions. Participation in the standing self-defense competition is required by all Delaware Combat Sports students in order to participate in the tournament.

Entry Fee: \$5.00 per competitor, per division (No spectator fees)

Rules (Standing Self-Defense):

1. A coach will be the attacker for the competitors.
2. The competitors are graded on how many techniques they know.
3. Novice competitors are graded on how many techniques they know not on how well they know them, Intermediate and Advanced will only get credit for knowing a technique if its performed correctly.
4. In order for competitors to compete in the regular tournament, they must score better than they did in the previous tournament.

Rules (Jiu-Jitsu):

1. All Jiu-Jitsu matches are 3 mins
2. GI and NOGI use the same rules and scoring system
3. Jiu-Jitsu Scoring:
 - a. Takedown = 2pts
 - b. Guard pass = 3pts
 - c. Sweep = 2pts
 - d. Knee mount = 2pts
 - e. Mount = 4pts
 - f. Back mount = 4pts
 - g. "Pulling" or "jumping" guard and/or "sitting" = penalty of 4pts
4. Tie breaker:
 - a. Competitor who was in a dominant position when the match ended wins

Age divisions: 5/6, 7/8, 9/10, 11/12, 13/14

Weights: Competitors will be grouped together by similar sizes. If needed, a second or third weight class for an age group may be created.
