**Rules:**

1. National Federation Rules
2. All Periods are 1 – 1 – 1
3. Director has the right to combine age groups, weights, etc.
4. Ages are as of the day of the tournament
5. Wrestlers may compete in more than one age group and weight class
6. Novice wrestlers are under 1 year of experience
7. Open Wrestlers are 1 year or more experience
8. Wrestlers with more than 1 year experience who enter the Novice divisions will be disqualified from the current tournament and all future tournaments as well.
9. All wrestlers, coaches, parents and spectators must follow all Delaware Combat Sports and Top Team Youth Wrestling Club facility rules. There is zero tolerance for unsportsmanlike conduct from anyone.
10. There is absolutely no food or beverages (except clear, water only) permitted in the facility.
